Mayor Snyder opened the public hearing on the matter of proposal to dispose of real estate lot 9 in the Breda third addition. No members of the public spoke to the matter and the Clerk reported no oral or written comments. Mayor Snyder declared the hearing closed.

Fire Department report was heard from Dan Wiskus. Advised the Fire Department was awarded a \$3000 grant from the Carroll County Foundation that will be used to purchase truck scene lighting.

Public Works report was heard. Request made by public works department for training for Certified Pool Operator license on March 15th and 16. Motion approved by Boeckman, seconded by Agan. Motion carried. Council considered license renewal with FCC. Motion approved by Agan, Seconded by Uhlenkamp. Motion carried. Council considered resolution 2022-02-03 of electric reliability plan. Roll call vote was held. All present voted aye.

Council discussed the fact that the electric wholesaler is increasing rates. Council considered if necessary to pass that increase to the local residents. Council agreed not to increase rates at this time. Motion by Boeckman, seconded by Tiefenthaler. Motion carried.
